ISO 45001 Occupational Health and Safety Management Systems is an internationally recognised standard used to improve employee safety, reduce workplace risks and create better, safer working conditions for management, employees and visitors. It gives guidance which enable organisations to put in place procedures and processes provide to prevent and/or reduce work-related injuries and illnesses. More importantly, the system proactively promotes continual improvements in occupational safety and health performance.

ISO 45001:2018 is applicable to any organisation that wishes to improve their workplace health and safety performance by establishing, implementing and maintaining an occupational health and safety management system. The system promotes the eliminating of hazards and minimising health and safety-related risks (including system deficiencies), as well as take advantage of occupational health and safety opportunities. The system also addresses occupational health and safety management system non-conformities associated with its activities.
