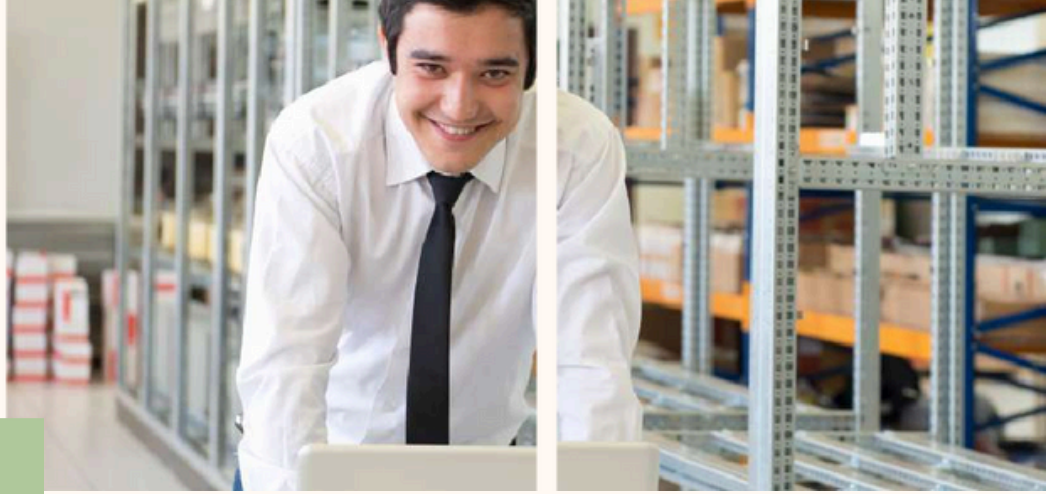
## INCREASED EFFICIENCY, RECOGNISED GLOBALLY
